Financial Resources:

1. [Meyrow Foundation](#): Grants available to churches with members who are directly living with Parkinson's disease. The grant funding can assist with the cost of updating and improving physical accessibility in the persons church and in their home. 2. [Koch Foundation Inc.](#): A parish in our diocese received a \$45,000 grant from them in recent years not necessarily related to capital expenditures.

[Community Facilities Programs | Rural Development Direct Loan and Grant \(usda.gov\)](#): Non-profit religious organizations could potentially qualify for loan/grant as long as the church was also providing services to the public such as a childcare services, community gardens/kitchens, food banks/pantry, healthcare services or private schools, etc.
4. [Invest DSM](#): Option available for Des Moines metro churches. Their mission is to provide holistic and innovative solutions that strengthen neighborhoods. They do this work through strategic investments in real estate and partnerships to improve quality of life.

5. [Greater Des Moines Habitat for Humanity](#): They serve Polk, Dallas, and Jasper Counties through a [home preservation](#) program that includes critical repairs, weatherization, and accessibility services. They are open to discussion on leveraging this program to serve local parishes. Assistance with ramps, grab bars, new steps, accessible restrooms, etc. so that people can be active in their community. Habitat does not charge for labor but does require volunteer involvement in each preservation project. Grant funding to support the projects may be available. For other counties in southwest Iowa please contact Jenna to be introduced to Habitat for Humanity in your area to see if they would be open to similar type projects.
6. [Iowa Knights of Columbus](#): Knights of Columbus Council may have funding and physical assistance available to assist with physical accessibility projects at a parish. Your local Council can also connect with the District Council contact for additional support and potential funding.
7. [Catholic Foundation of Southwest Iowa](#): Provide grants for parishes, schools, non-profits that fall within our Catholic values in the geographic are of the Diocese of Des Moines. Grants are available for potential partial funding of physically accessibility improvements (other than bricks and mortar). - The Great Plains ADA Center provides information, guidance and training on the Americans with Disabilities Act and related laws to the service region of Iowa, Kansas, Missouri and Nebraska. Our services are designed to meet the needs of a wide range of users, from individuals with disabilities and their families to architects, building code officials, educators, state and local governments, and businesses. We combine expertise on ADA guidelines and regulations with years of hands-on experience to provide services that are effective, targeted and user-friendly.
- We provide informal guidance on the ADA, including help understanding the standards and how they apply to various entities. We can offer guidance on what is required for accessibility, and also provide some recommendations for independent contractors who can assess your situation at your facilities. Resources for funding is something we can check into as they do exist but are few and far between.
- We are experts on the ADA, which is a minimum set of standards. There are some issues of accessibility that the standards don't quite cover, for example, that the required clear floor space for a wheelchair is 48 inches, but many motorized mobility devices require 54 inches, which is above the requirements set by the ADA. So, while we can get you started on ensuring your spaces are accessible, there may be further considerations to fully ensure all individuals have access.

- Contact the Industrial tech department at a local high school or community college to inquire if they would be interested in a project like this. Boy scouts, Lions Club, Rotary or other service groups may build ramps in your area.
 - Contact medical supply companies/home health care agencies to find out if temporary ramps are available for rent or purchase.

There may happen to be a ramp or other items that may be what you are looking for.
