## **eCorp Online Banking Security Protection:**

### **Fraud Detection**

- West Bank utilizes an anomaly detection process through Nice Actimize for all ACH originated transactions, wire transfers, and eCorp login sessions to help protect against fraud.

### **User Controls**

- eCorp users may be set up based on permission levels with account information segregated by user functionality, account number, and capabilities within each particular account. Dual authorizations are recommended for ACH and Wire transactions.

### **Security Tokens**

- eCorp Business Online Banking requires a token provided by West Bank. The token is used to generate a unique security code each time a user logs into eCorp to access ACH, wire transfers, remote deposit and other features.

## West Bank offers a two-in-one solution through Positive Pay and ACH Fraud Filter

### The benefits include:

- **Protection from internal and external fraud:** Both Positive Pay and ACH Fraud Filter help protect your business 24/7 and alert you of potential counterfeit items or suspicious activity
- **Control:** Fraud and accounting input errors can cost your business many hours in lost productivity. Positive Pay gives you the control to react to each exception as it is detected

### Positive Pay and ACH Fraud Filter

- Positive Pay is an automated check-matching service that compares checks presented for payment against a database of checks previously authorized by your business

### How does it work?

- Positive Pay automatically matches presented checks (check number and amount) against your list of previously authorized checks. If a check does not match, it becomes an “exception item” and you’re notified so you can review the item and confirm or deny payment
- ACH Fraud Filter allows you to set up rules for your ACH transactions. Any time an ACH is presented that violates one or more of your rules, you’ll be notified so you can review the transaction and decide to accept or deny it

## What is it?

- Automated Clearing House (ACH) is a convenient way to make payments and collect funds electronically
- ACH can be used to issue payroll, process accounts payable and move funds between accounts
- Can also be used to collect payments from members, vendors or contractors -With electronic processing, funds move faster, the risk of errors and fraud is reduced

## How does it work?

- Rather than writing and mailing checks or manually processing accounts receivables, ACH allows you to send and collect funds electronically.
- Once you've set up the routing and account number for the payee, all of their data is retained, saving you time and money.
- Have quicker access to funds.
