## Fidelity Update

We are happy to announce we that we will be out of the quiet period as of Noon Eastern Time, Thursday, July 20th. At that time, employees can go to <u>www.netbenefits.com</u> to set-up their account access and log in to:

- check their account balance
- confirm their beneficiaries
- set-up banking information for loan repayment
- set mailing preferences for communications from Fidelity

Please note:

- If employees have or have had prior Fidelity access, their log in information will be the same. When they log in they will also see their Christian Brothers Retirement Savings Plan.
- If employees have outstanding loans, the account balance they will see is NET of the loan amount. Their total account balance is the sum of the account balance shown and the amount of the outstanding loan balance.
- Retired participants receiving installment payments will need to set up their banking information to continue electronic payment.

The transition website (<u>www.myfidelitysite.com/CBS403b</u>) will be updated tomorrow to communicate to employees that the quiet period is over. Postcards will also be mailed. Be sure to remind employees to register on the transition website for the upcoming *Get to Know Fidelity* webinars.
